Day 1 (For Landscape Professionals):

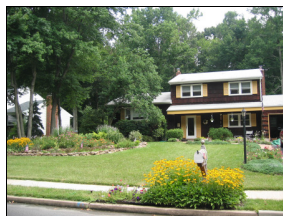
